- 4. To hear discussion on the question of "Shall the Town of Hampton transfer \$100,000 from the General Fund to Capital Non-Recurring Land Acquisition Fund for the purpose of purchasing two parcels up to 20 acres total, for up to \$75,000, from Ron Parrow?"
- 5. To hear discussion on the question of "Shall the Town of Hampton transfer \$100,000 from the General Fund to Capital Non-Recurring Building Fund for the purpose of finishing improvements at the Town Hall?"
- 6. To hear discussion on the question of "Shall the Town of Hampton appropriate \$5735 from the Hampton Elementary School Capital and Non-Recurring Fund for the purpose of improving the server room?"

Edwards property for the sum of \$210,000 to be expended from the Town of Hampton's Capital Non-Recurring Open Space Fund and \$101,500 reimbursed through the State of Connecticut DEEP Grant?".
- 2. "Shall the Town of Hampton transfer \$100,000 from the General Fund to Capital Non-Recurring Land Acquisition Fund for the purpose of purchasing two parcels up to 20 acres total, for up to \$75,000, from Ron Parrow?"
- 3. "Shall the Town of Hampton transfer \$100,000 from the General Fund to Capital Non-Recurring Building Fund for the purpose of finishing improvements at the Town Hall?"

4. "Shall the Town of Hampton appropriate \$5,735 from the Hampton Elementary School Capital and Non-Recurring Fund for the purpose of improving the server room?"
