SPECIAL MEETING MINUTES MONDAY, NOVEMBER 9, 2015 6:30 PM

1. CALL TO ORDER

The Board re-entered public session at 7:15 PM. John Burnham moved to appoint Andrea Lavery as principal of Hampton Elementary School effective November 17, 2015 at a prorated salary of \$100,815. Peter Smat seconded the motion. There was no discussion and the motion passed unanimously.

4. RATIFICATION OF COLLECTIVE BARGAINING AGREEMENT WITH HAMPTON EDUCATION ASSOCIATION

Ann Gruenberg moved to enter executive session for the purpose of discussion of the collective bargaining agreement with the Hampton Education Association. Maryellen Donnelly seconded. Superintendent Berglund, Stacie Ropka and Mark Becker were invited to join the executive session. The motion passed unanimously.

The Board re-entered public session at 7:35 PM. John Burnham moved to ratify the agreement between the Hampton Board of Education and the Hampton Education

Association from July 1, 2016 – June 30, 2019. Ann Gruenberg seconded the motion, which passed unanimously.
