B. Budget Workshop for FY 2013-2014

Budget information and requests are still coming in at this time.

Animal Control - eliminating some line items as they are covered by NECCOG's fees.

Health Insurance - slight increase in premiums. Discussion followed regarding employee contribution percentages for full time employees.

Green Energy - anticipate keeping same budget numbers for FY 2013-14 as current fiscal years.

Capital Non-Recurring - Town Hall roof should be addressed and added to 5 year plan.

SIMPLE IRA - budget numbers need to go up a little as several employees have joined the plan, that were not previously enrolled.

Salary adjustments were discussed for Public Works Department employees, Administrative Assistant and First Selectmen positions. Selectmen Grindle volunteered to look into salary comparisons with surrounding towns.

Trucking/ Transfer Station - a training/ re-certification class is needed; fees are unknown at this time.

Utilities - suggested that the line items be reformatted and combined in to one section for clarity.

WINCOG - increasing their dues

Open Space - adjust to \$30,000

Land Acquisition - adjust to \$30,000
