Old Business

Little River Updates

- Kevin continued the workshop to create a master/management plan for the property. The group briefly reviewed the SWOT analysis which was completed at the August meeting and decided to first focus on the property's Opportunities.
- These opportunities will be broken down into short (0-3yrs), medium (4-10yrs) & long (11+yrs) term goals. These goals will be used to complete the master plan and substantiate future funding requests.
- The group discussed the need for regular property maintenance and agreed that volunteer efforts are critical to have but can't be the sole source of maintenance on this property. John T. agreed to discuss this maintenance need with the Selectmen.
- Marc spoke with the Antiquarian Society and updated the group on the seven former mills on this portion of the river.
- There are no updates on the STEAP application requesting funds to cover the cost of the ADA boardwalk and parking lot.
- Kevin will ask the Town planner to make an application to the NDDB to determine what type of protected species are on the property.
- The group noted that volunteer hours are still being tracked and these hours need to be forwarded to Penny, who's tracking this time.
