Item 1: Audience for Citizens:

Tom Cavanagh noted that Jody Charron should be identified in the Minutes of January 12, 2010 as a "supervising forest products harvester" instead of a "licensed forester".

Item 2: Additions to the Agenda

Motion: Maura Robie, seconded by Martin Mlyniec, to add to the Agenda under No Permit Necessary consideration of an Application from Gloria Burell of 603 Pudding Hill Road with the proposed activity of selective timber harvest. Motion carried unanimously.

Item 3: Approval of Minutes – January 12, 2010

4.1. WP0110-01 EASTCONN, Inc. Applicant; 376 Hartford Turnpike; Construction of new 16,500 sq. ft. addition and associated site improvements, including an expanded parking area, a new septic system, a new electrical service, an expanded storm drainage system and an above ground storm water management area (i.e. detention pond) that reduces the post-development peak rate of storm water runoff to the pre-developed condition. Application Review [19.6 a.] fee of \$30 has not been received. Additional fees to be calculated and collected. Action pending.
