PUBLIC HEARING

1. Application for a home business at 20 Parsonage Road, property of Estate of Charlotte Rowe/James Oefinger for a tree service business in the RA-80 Zone.

Chair Grindle called the public hearing to order at 7:00 pm.

Mr. James Oefinger addressed the Commission. He noted that his business, Affordable Tree Service, has been in business for 18 years and that he doesn't anticipate any changes to the amount of equipment soon. Planner/ZEO Martha Fraenkel explained the Zoning Regulations regarding home businesses and the supplemental Regulations for contractors, which in her opinion, would apply to the applicant. She reviewed the specific requirements for a home business. Grindle noted that the applicant would need to provide a map showing the current conditions of the property, a map showing the plan to improve screening on the property, a list of vehicles/equipment housed on the property, and a plan for managing any hazardous materials and hazardous waste.

The audience was invited to address the Commission. Ron Gregoire, 11 Parsonage Road, has been a neighbor for ten years. He noted the property has been kept well, noise has not been a factor, and he has no problem with the business. Russ Moffet, 23 Parsonage Road, also spoke in favor of the applicant. He expressed concern that having to provide professional plans for the application process was an unfair burden on the applicant. Selectman Mike Chapel spoke in favor of Mr. Oefinger and his business. Susan Crawford, Cedar Swamp Road, questioned why the business had operated for 18 years without a permit and what the renewal procedure involved.

The Commission stated that the map/plan required for the application did not need to be professionally prepared. Fraenkel could supply Oefinger with a copy of a property map that he could use to produce the plan himself. The hearing was continued until September 28, 2015 at which time Mr. Oefinger will present a map of existing conditions, his map/plan for screening the property, a list of vehicles/equipment housed on the property, and a plan for managing hazardous materials/waste. The Commission will also consider changing the regulations regarding how many and what types of vehicles are allowed to be stored on a property. Chair Grindle tabled the public hearing at 8:07 pm.
